By advancing deposit to Eco Tours International, the depositor therefore agrees to be bound by the below terms and conditions. All trip participants must complete a trip application/Liability Release and Assumption of Risk Agreement and medical form. Strenuous trips require a physician's release on the medical form. We require medical rescue insurance for all trip participants.

Your Responsibilities

- **Medical considerations:** *If you have any medical or psychological conditions, it's very important you let us know well before departure so that we can make extra arrangements if necessary.* Trip leaders have the right to disqualify anyone at any time during the trip if they feel the trip member is mentally or physically incapable to continue and/or if a trip member's continued participation jeopardizes the group's or his/her own safety. Under these circumstances refunds are not given. We require emergency medical rescue insurance for all trip participants.

Eco Tours International is not a medical facility and therefore has no responsibility regarding medical advice, medications or inoculations that you or your doctor deem necessary for your safe participation.

Hospital facilities for serious problems are often unavailable, and evacuation can be prolonged, difficult and expensive. Trackers International assumes no liability regarding provision of medical care. By signing the Liability Release and Assumption of Risk Agreement, you agree to pay for emergency evacuation and emergency medical care.

- **Your obligations as a trip member**
By participating in a **Trackers International or Eco Tours International** trip, including a trip booked for you by Trackers International or Eco Tours International, you assume certain obligations to Trackers International or Eco Tours International and the other trip members. It is your responsibility to:
 - Understand the conditions implied in the trip descriptions. Many trips are adventurous and may involve exposure to dangerous wildlife or other potentially risky situations.
 - Select a trip that is appropriate to your interests and abilities
 - Prepare for the trip by familiarizing yourself with the trip itinerary and trip preparation materials
 - Bring appropriate gear and clothing
 - Obtain all necessary visas
 - Follow considerate standards of personal hygiene in order to reduce risk of contracting diseases
 - Follow considerate social behavior with other trip participants and respect their habits
 - Act in an appropriate and courteous manner befitting the customs of countries you visit
 - Complete the trip itinerary as scheduled (or as adjusted by your trip leader as necessary)
 - Respect the countries we visit by using environmentally safe products, staying on established routes of travel and not littering.

We reserve the right to decline to accept or retain any person as a tour participant should such person's behavior, health or mental condition impede the operation of the trip.

OUR LEGAL LIMITATIONS-PLEASE READ CAREFULLY

Trackers International and Eco Tours International may contract with independent contractors to provide transportation, guide services and/or all other related travel services. We assume no responsibility, however caused, for injury, loss or damage to person or property in connection with any service provided by an independent contractor or resulting directly from the following: - acts of God - detention annoyance - terrorism - thefts - pilferage - force majeure - civil disturbances - government restrictions or regulations - strikes - delays and expenses arising from quarantine - failure of any means of conveyance to arrive or depart as scheduled - discrepancies or change in transit or hotel services over which we have no control.

We reserve the right to make reasonable changes in the itinerary where deemed advisable for the comfort and well-being of trip members, or for unforeseen events. By advancing a deposit to Trackers International, the depositor thereby agrees to be bound by the above terms and conditions.

Cancellations

If you decide to cancel your trip, the following fees apply at the time (prior to departure) we receive written notice of your cancellation. *Some trips may have special cancellation or transfer fees; if so, they will be listed on your trip itinerary.*

95 days to Registration	25% of Trip Cost
65 to 95 days	50% of Trip Cost
0 to 65 days	100% of Trip Cost

Trip cancellation insurance

Should you have to cancel your trip due to illness or death of a family member or yourself, this insurance protects all your deposits and payments for both air and land cost. We strongly recommend that you purchase this insurance. We require medical rescue insurance for all trip participants.

If we cancel a trip

Trackers International and/or Eco Tours International reserves the right to cancel a trip for force majeure or any other circumstances beyond our control. We also reserve the right to cancel any trip if sign-up is inadequate to make the trip economically feasible for us to operate. If this happens, we give a full refund of land cost. However, we are not responsible for additional expenses incurred by you in preparing for the trip (e.g., non-refundable air tickets, visa fees if applicable, gear or medical expenses).

Refunds

We do not give any refunds for unused hotel rooms, meals, sightseeing trips or trek arrangements. Land cost is quoted as a package; credits are not given for services not used.

All participants must sign the following Liability Release and Assumption of Risk Agreement. Please send us the original document and keep a photocopy.

Liability Release and Assumption of Risk Agreement

I acknowledge that I have voluntarily chosen to participate in the trip referenced on the trip application. In so doing, I acknowledge that I may be subjecting myself to dangers and hazards which could result in illness, injury or death. I also acknowledge that there are inherent risks and dangers which may arise at any time during the trip. I am specifically familiar with and accept the risks of the dangers and hazards referred to in the trip materials which have been provided to me. I am aware that medical services or facilities might not be available while I am participating in the trip.

In consideration of my being permitted to participate in the trip, I agree to **assume all risks** of illness, injury or death and agree **not to sue** and to **release from liability and indemnify Trackers Earth Inc., Eco Tours International, LLC. DBA Trackers International, OWLink Media, 8 Shields**, their owners, officers, agents, contracted tour operators and employees and other persons or entities involved with this trip, from all actions, claims or demands for injury, loss or damage regardless of the cause resulting from my participation in the trip.

I understand that Eco Tours International, LLC, DBA Trackers International and may contract with independent contractors to provide services on this trip, including transportation, travel services and guide services. I understand and acknowledge that Eco Tours International, LLC, DBA Trackers International has no control over and assumes no responsibility for the actions of any independent contractors involved in providing any services on this trip.

I agree Oregon State will be the forum for resolution of any dispute related to my participation in this trip.

The terms of this agreement shall serve as a release and assumption of risk binding on my heirs, executor, administrator and all members of my family, including any minors accompanying me.

I have carefully read the reservation information, I have familiarized myself with all information provided to me about this trip, and I agree to all stated conditions set forth in the Reservation Information specifically including the section outlining my responsibilities and obligations as a trip member.

I grant Trackers International and Eco Tours International the absolute right to copyright, re-use, publish and republish by any medium, including electronically, any photos or videos of me or in which I may be included, that may be taken while participating in an Trackers International trip or an Eco Tours International. I also consent to the use of any printed matter in conjunction therewith.

I have carefully read this agreement. I understand that it is a **release of liability** and a contract between me and **Trackers Earth Inc., Eco Tours International, LLC. DBA Trackers International, OWLink Media, 8 Shields,** and/or its contracted tour operators or affiliated organizations, and I sign this agreement of my own free will. If any part of this agreement is deemed unenforceable, all other parts shall be given full force and effect.

*If I am signing on behalf of a minor, in addition to the above, I also agree to RELEASE, HOLD HARMLESS AND INDEMNIFY the entities named above for any claims of the minor. I agree to be responsible for any medical expenses incurred by the minor.
